





# **USING ZOOM FOR VIRTUAL TEI**

We will be using Zoom as our technology platform for TEI. Most plenary sessions will be broadcasted as webinars, and attendees will be in "listen only" mode (no audio or video capabilities). Attendees can ask questions through the Q&A function at the bottom of the screen.

For most breakout sessions, you will be in a Zoom meeting room. We invite all participants to join by video camera in the breakout sessions for engaging discussions with your peers. To help minimize background noise, all participants will enter Zoom meeting rooms muted, and to ask a question or participate in the conversation you will simply need to unmute yourself via the Zoom controls in the lower-left-hand corner of your screen.

# **Zoom Technology Tips**

If the foundation sends multiple leaders to the Institute, these questions can help stimulate discussions about what each participant took away from the Institute, and to help you turn those collective learnings into specific actions to take forward in your work.

Note: We recommend that you share these questions in advance of your scheduled debrief call to allow individuals time to reflect and come to the discussion with specific ideas and suggestions.

Who was your favorite/most compelling presenter at the Institute? What specific message(s) or insight(s) did they share that were of most interest to you? Were there any comments from other speakers that really resonated with you?

What did you hear that was surprising to you? Were there any speakers or messages that you disagreed with?

What are three things you as an individual board (or prospective board) member will do over the next three months to build on what you learned at the Trustee Education Institute?

What is one way your foundation could change or adapt its current practices in the areas of governance, grantmaking, or family relationships based on what you heard at the Institute? How would this help your giving? Who can make this change happen?
