

Grounding Your Family Philanthropy Effort


Motivations and values are fundamental to building a family philanthropy structure. Give yourself a solid foundation of clear motivations and values to ground your effort in the long-term.

Motivations


The inspiration and rationale behind why a donor gives—the purpose and the aim, the core of why one commits to philanthropy





Motivations

Philanthropy is a deliberate choice, and it is one that you have to assert time and time again. Motivations give language to that continuous choice.





Values

Values | Noun

val·ues | \ 'val-()yüs

When we talk about values, we mean the core principles, characteristics, and behaviors that underlie all our decisions and actions—ones that we feel are most importance and influence our everyday lives and philanthropic choices





Values

Values provide a common purpose and shared direction. They guide decision making and help donors focus their giving around an aligned goal.







Giving Styles & Motivations for Giving

Giving styles often follow a natural evolution from informal and relational to intentional and structured.





Giving Styles

Giving styles and approaches often stem from and reflect a family's motivations. And they often evolve over time.





Questions for Reflection

- What motivates you to give?
- What do you want to accomplish with this effort?
- What are the values that are important to you and your family?
- Why did you choose the identified values?
- How will you align your giving with your values?



How do families define and explore their motivations and values?

Five Tips for Getting Started

- 1. Take your time: This process is slow-going, and requires patience and a willingness to listen to all voices
- 2. Hire a trained facilitator: A facilitator can ensure all voices are heard in a safe space
- 3. Tell stories: Sharing stories about family traditions, values, and passions helps to get these conversations moving
- Identify conflicts and trouble spots: Opening naming topics where there are 4. strong disagreements may help reduce tension and allow families to focus on areas where there is agreement
- 5. Document the process for future generations: Record the founders, board members and others discussing family values so others can refer to these principles later on



Identifying Your Motivations & Values

The process for identifying motivations and values consists of two stages. First, families need to engage in a conversation with each other and dig into what's driving them, what they want to achieve, and what principles they want to maintain. Second, they need to name those the motivations and values by articulating statements that reflect the outcomes of honest dialogue.





Define Values Statements


Vision

Translate Your Motivations & Values


Translating motivations and values is about how you apply the motivations and values into the work. Families can use their values as a measure or litmus test for the work you're doing.
