

What are the phases of development of a family governance system?

What phase is your family in?

QUESTION	CHAOS	COORDINATION	COHESION
Have you ever had a family meeting?	No	Yes, a few	Yes, many
Do family members know the family's guiding principles?	No	Maybe	Yes
How are family decisions made?	Unclear (often dictated by patriarch or matriarch)	Varies	According to clear processes
Does the family have a forum for discussion?	No	Yes, one	Yes, several (each has different purpose)
How formal is decision making?	Very informal	Varies	Clear lines of authority and loci for decision making



Why is effective family governance important to a family philanthropy effort?

The social contract

- Family philanthropy's growing importance
- Guidance toward a higher goal
- Responsibility to all stakeholders





Practical Tips

- $\sqrt{}$ Focus on why along with what and how
- √ Encourage open communication
- √ Make sure meetings are productive
- √ Re-visit principles and policies every few years
- √ Follow consistent practices





Closing Thoughts

- It's harder to focus on governance today than before
- Tradition and anxiety can hold back effective governance
- Merely setting up a forum doesn't mean you have governance
- Younger generations expect more voice/vote
- Families can transfer effective governance from one area to another
- Governance needs inclusive leadership
- Outsiders can guide but can't lead the family's work
