NCFP Welcomes Three New Members to Its Board of Directors

WASHINGTON, D.C. – The National Center for Family Philanthropy (NCFP) is pleased to announce three new members have been appointed to its Board of Directors. Samuel Bonsey, Gilbert Miller, and Anthony Richardson will each serve a three-year term. Together, they are representative of NCFP's major constituencies: family philanthropy trustees, family philanthropy staff, and philanthropy-serving organizations.

Sam Bonsey is co-founder and executive director of The ImPact, a global network of families committed to aligning their assets to their values. To NCFP, Sam brings a spirit of innovation and a deep understanding of impact investing and the family philanthropy landscape. Sam is Vice-Chair of Keller Enterprises, a family office committed to using both investment and philanthropic resources to pursue its mission. In 2010, Sam co-founded the 2Seeds Network, an incubator of community-driven development projects in Tanzania; in 2019, 2Seeds merged with Spark Microgrants, on whose board Sam now serves. He was recognized in 2015 by Forbes as a "30 Under 30" Social Entrepreneur.

Gilbert Miller, boasts over two decades of experience as a family philanthropy trustee—as chair of the Bradley-Turner Foundation and as trustee of the Beloco Foundation. He has extensive first-hand experience with successful multi-generational giving and is a previous co-chair of NCFP's Board Chair Peer Network—a space for board chairs to share best practices and address common challenges. In his trustee roles, Gilbert prioritizes defining the foundations' missions and strengthening governance.

As the current president of The George Gund Foundation and former executive director of the Nord Family Foundation, Anthony Richardson brings tremendous leadership experience and a solutions-oriented approach to addressing challenges that family philanthropy faces. In 2011, he was elected as a councilmember-at-large in the City of Lorain, OH, becoming one of the youngest people elected to a citywide seat. Anthony was a recipient of Philanthropy Ohio's 2017 Emerging Philanthropist Award and serves on the boards of the Center for Effective Philanthropy, Philanthropy Ohio, and Funders Together to End Homelessness.

"I am excited by the diverse perspectives, experiences, and skill sets Sam, Gilbert, and Anthony will bring to NCFP and I look forward to their contributions to the organization's continuing evolution."
