**Khalilah Burt Gaston** is a proven leader, skilled strategist, and passionate advocate for inclusive communities with more than 20 years of experience in social sector leadership, governmental relations and cross-sector partnerships. role, Khalilah is responsible for managing the daily operations of the foundation and an extensive network of relationships to support the foundation's strategic pillars. Moxie Jean won a Chicago Innovation Award in 2013 and was a 2012 portfolio company of renowned tech accelerator Excelerate Labs (now TechStars Chicago). Moxie Jean was acquired by Schoola in 2015. Before starting Moxie Jean, Sharon spent 12 years as a staff member and consultant to private foundations, including the Bill & Melinda Gates Foundation, the Pew Charitable Trusts, and dozens of small family foundations, on issues ranging from strategic planning and outcome management to engaging your family in philanthropy. Sharon has an M.A. from the University of Pennsylvania and a B.A. (summa cum laude) from the University of Toledo. She lives in Denver with her husband and their three children.
